Instructions

1. Only use this form to ask the court to erase convictions for offenses committed before January 1, 2000.
2. Complete the form, swear to the contents, and sign it before a Notary Public, Commissioner of the Superior Court, Clerk, or other proper officer.
3. Attach the following documents to this form when you file it:
 - a. A copy of your Criminal History Record from the State Police Criminal Records Unit.
 - b. If you were released on parole or special parole and did not have probation as part of your sentence, a letter from the Department of Corrections (DOC) confirming that you have completed parole for every offense for which you have ever been convicted.
 - c. If you had probation as part of your sentence for any conviction, a letter from Adult Probation Services confirming that you have completed probation for every offense for which you have ever been convicted.
4. File the form in the court location where you were sentenced for the crime that you are asking the court to erase. If you were sentenced in a court that has since closed, see the chart on the back of this form to find where you should file your petition.

Petition for Clean Slate erasure

I, the defendant named above, state under oath that:

1. The crime(s) listed above that I am asking the court to erase under Clean Slate happened before January 1, 2000.
2. **Waiting period:**
If the crime(s) I am asking the court to erase are felony conviction(s), I have not been convicted of any other crimes within the last 10 years.
If the crime(s) I am asking the court to erase are misdemeanor conviction(s), I have not been convicted of any other crimes within the last 7 years.
3. **Sentence completion:**
I have completed serving the sentence of imprisonment, including any parole or special parole, and any period of probation or conditional discharge that I was sentenced to for all the crimes that I have ever been convicted of.
4. **DNA sample:**
If I was required to submit a DNA sample under General Statutes § 54-102g for any crime that I have ever been convicted of, I have submitted my DNA sample.
5. **Sex Offender and Deadly Weapon Offender registration:**
If I was required to register as a sex offender under General Statutes §§ 54-251 to 54-254 or I was required to register as a deadly weapon offender under General Statutes § 54-280a for any crime that I have ever been convicted of, I am no longer required to register as a sex offender or deadly weapon offender for any crime.
6. **Standing Criminal Protective Orders:**
I am not currently subject to any standing criminal protective orders for any crime that I have ever been convicted of.
7. **Criminal fines:**
I have paid the criminal fine(s) imposed as part of my sentence for all the crimes that I have ever been convicted of.

I certify that the statements above and on any attached documents are true, complete, and correct to the best of my knowledge and belief. **I understand that if I have willfully misrepresented (lied about) the statements above or any of the information I have attached, I may have criminal charges filed against me.**

Where to get your Criminal History Record:

The State Police Criminal Records Unit keeps the official record of criminal convictions. The State Police Criminal Records Unit requires all requests for a copies of Criminal History Records to be made using the State of Connecticut Criminal History Record Request Form (DPS-0846-C) and mailed to:

Note: General Statutes § 29-11(c)(iii) requires the State Police Criminal Records Unit to charge \$75 for Criminal History Record requests.

How to get a letter from DOC confirming you have completed parole:

You can ask DOC for a letter confirming that you have completed parole for every offense for which you have been convicted by e-mail to the DOC Central Records office at: DOC.CleanSlate@ct.gov.

State in your e-mail that you are asking for a letter of parole completion for Clean Slate and include the following information so DOC can find your records and contact you with any questions:

How to get a letter from Adult Probation confirming you have completed probation:

You can ask Adult Probation Services for a letter confirming that you have completed probation for every sentence for which you have been convicted by e-mail to Adult Probation Services at: CleanSlate.Requests@jud.ct.gov.
